Adopting an "indifference principle"

Last autumn I spent a couple a months out in a big international company looking at their supply chain risks and learnt a lot. One of the lessons was that the link in the chain that has the best possibilities to handle a risk, e.g. by taking preventive measures, seldom has the incentive to fully do so simply because the main negative consequences of a disturbance spreading to other links are often taken by those other links and not by the link that "caused" the disturbance.

What is needed is, as I see it, the introduction and implementation of a "disturbance causer pays-principle", like the "polluter pays-principle" that exists within the environmental area. Implementation of such a principle for the focal company on e.g. the supply side would mean that there are two equal alternatives. Either is the flow normal and the focal company will hopefully make a profit out of it. Or is the flow disturbed and the focal company will get full compensation from the disturbance causer, e.g. a supplier not delivering on time, for the negative economic consequences that the disturbance has caused it including lost profit. The two alternatives would be "equal" and the focal company indifferent. An "indifference principle" has been adopted.

Adoption of such a principle is vital because the present situation with its *lack of incentives* makes the supply chain more vulnerable than it would have been otherwise, and consequently *less competitive* – at least in the long run.
